NCC 2019 Hours of Operation – TEMPERATURE CHECK AND THERMAL COMFORT REPORT PLUGIN

Please remember that the plugin is only a calculation tool. It is up to you to ensure that you are following all relevant NCC procedures, including setting up your building model correctly and verifying the calculated results produced by the plugin.

The temperature check and thermal comfort report plugin only analyses hours which are included in the annual *hours of operation* for the space.

The definition of *hours of operation* in the NCC is "hours where the occupancy of the space is greater than 20% of the peak occupancy" (p.654 Volume One). Unfortunately, this definition is difficult to interpret when combined with the actual occupancy schedules and hours of operation specified in the tables contained in Specification JVc. In many cases the occupancy in the tables is equal to 20%, and according to the literal interpretation of the definition, these hours should not be counted as hours of operation, and should be excluded from the analysis. A common-sense reading of the tables indicates that this does not reflect the intention to include hours where the space is occupied by people who expect to be comfortable. Simply including the hours where occupancy is equal to 20% is also not adequate, however, as this would include some hours for which the space is not conditioned.

We have decided to interpret "hours of operation" for the plugin in the following way:

Hours are included in the analysis if (following the tables in Specification JVc):

- The occupancy is greater than 20% OR
- The occupancy is equal to 20% AND the air conditioning schedule is "On"
